M/S/P- Corrock/ Price- Approval of Reports

New Business

Discussion: The BOD Fund was established several years ago at \$29,000. The present value of the original \$29,000 investment is estimated to be about \$50,000. The fund is accessible to all disciplines in the IMD.

M/S/P- Bailey/Corrock- Disbursement of BOD monies

- That \$50,000 principal be maintained in the BOD fund and that future earnings be reinvested so as to maintain the value of that principal measured in future dollars.
- That monies currently in the BOD fund in excess of \$50,000 be distributed to the 5 disciplines (alpine, nordic, freestyle, jumping and snowboard) in proportion to discipline membership on April 1 of the year of distribution.
- That future earnings be reinvested as judged annually to be adequate to maintain the value of the principal.
- That future earnings that are in excess of earnings reinvested to maintain principal be distributed to the 5 disciplines in proportion to discipline membership on April 1 of the year of distribution.

M/S/P- Bailey/Hammer- Amend section 4.1 of the by-laws- ACC ex-officio members. Remove Master's Chairman and replace with YSL Chairman.

M/S/P- Corrock/ Price- Transfer the ACC investment fund to the IMD ACC. The fund will remain under the same brokerage but will be managed by the ACC and the IMD office. Add to the ACC fund and the BOD fund, a requirement of 2 signatures for a transaction. The signatures to be on file will be the IMD President, IMD Director and the IMD Treasurer.
